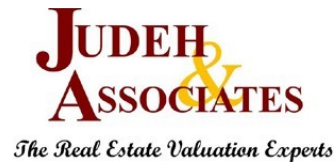
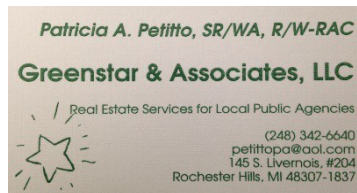

Presentation Highlights

“Early Roads in Metro Detroit”, by Paul Sewick

Each generation leaves its mark on the landscape in the form of roads, borders, and the built environment. Maps, as a result, are the documents which record this history. From the Native Americans whose trails have become expressways, to the modern subdivisions which outline the landholdings of eighteenth century French Canadian farmers; from the military roads that became Detroit’s radial avenues, to the government surveys which laid the foundation of our mile road system, this talk introduces Metro Detroit’s patchwork street system.

Raised in Metro Detroit, Paul Sewick has long been fascinated by its past and the way humans have altered its landscape. His love of history is reflected in the homes he has renovated in Corktown and Farmington Hills. A former board member of the Corktown Historical Society, and author of the Corktown History Blog, Sewick and his wife currently reside in Farmington Hills, where he serves on the Historic District Commission. Sewick is a freelance writer who also blogs about Detroit land development history at detroiturbanism.blogspot.com.

“Driverless Vehicles – Who’s behind the Wheel?” by Robert Norton

As technology for driverless vehicles advances toward reality, the movement places increased demands on our infrastructure, public policy, and our way of thinking. Mr. Norton will provide insights to this emerging technology, the obstacles to overcome, and policy considerations that will impact the future of our transportation network.

Robert Norton is an attorney at Hillsdale College who previously worked closely with emerging automotive technologies for manufacturers. He previously served as Assistant General Counsel for Chrysler LLC and Associate General Counsel for Visteon Corporation. His experience includes international patent negotiations, lobbying law, product liability law as well as complex litigation. While at TRW he headed one of the first teams to develop and deploy X by Wire technology for automotive use.

11:00 a.m. Chapter 6 Luncheon “How to Stay Cool in the Heat of Conflict”, 1-hr CEU

Have you often wondered why you keep holding on to a position during a heated conversation, knowing that if you could just let it go, things would turn out better? Given a choice, we'd all avoid conflict at all cost, but real life doesn't bend that way. So how can we come out of conflict more intuitive than when we first got into it?

We've heard that conflict is a way of life, but a healthy attitude toward this foe can help us maintain our cool and personally benefit from the sometimes-awkward conflict experience. We'll explore the importance of “falling out of love” with our position by taking a step back, building enough breathing space to keep cool-headed. The result: Dealing with conflict through the power of intention. Attendees will learn the merits of “peeling the onion” for an introspective analysis of the superficial and root causes of conflict. And how to “detach” from the struggle and “attach” ourselves to the right approach that meets the needs, interest and concerns of the other person.

1:00 p.m. “What I Should Have Said, But Didn't--Effective Communication Skills and Negotiations Success” 4-hour CEU workshop

Have you ever walked away from a meeting with a property owner, wishing you could have said something that would have changed the direction of the negotiations, or remembered something you could have said to better address the owner's needs and concerns? Effective communication doesn't start at the meeting, but through discovery during preparation before meeting with the property owner.

This 4-hour, highly interactive workshop will steer attendees to evaluate themselves in the negotiation process by proactively recognizing their own patterns of behavior and identifying potential shortcomings even before meeting with the owner. Layered atop basic communications skills of listening, questioning, empathy and patience is a simple process of See-Adjust-Measure, which helps the agent to keep an outwardly facing strategy based upon a common goal, common interest and common responsibility, and by being open, curious and aware of the owner's needs throughout the negotiation process. The targeted outcome of an outwardly facing strategy is an instinctive and natural flow of trust, understanding, and communication that binds a strong partnership, ensuring win-win results.

Carol Brooks, SR/WA, is the Owner of Cornerstone Management Skills, and internationally recognized and award-winning author and trainer. She is a Certified CLIMB Lead Instructor with the IRWA. She is the recipient of the Louise L. & Y. T. Lum Award for distinguished contribution to education for the right of way profession. Ms. Brooks is also the VEIT Instructor (online video training) for C213 and C100. She authored the course manual for C100 for both the VEIT and classroom editions. She is the Vice Chair of the Partnership for Infrastructure Professional Education, an effort to enhance course curriculum and instructor development for a worldwide audience. With over fifteen-years' experience in public utilities and local public agencies, her expertise includes easement and land acquisition, negotiation, easement valuation, permitting, easement law, project management, and eminent domain support. Carol received the IRWA's Mark A. Green Award for Journalistic Excellence and Outstanding Contribution to Right of Way for publication of four articles entitled, “The Art of Successful Negotiations.” She has served on the Editorial Board for Right of Way Magazine for ten years. She authored a standing column entitled, “Back to Basics” in Right of Way for 4-years and was rated #1 by a membership survey. She is currently a contributing author for ROW Magazine's teambuilding column.

As any ROW professional will tell you, creating positive community engagement and impact is vital to the success of any ROW project. But they will also tell you that this is much easier said than done! This course will provide you with those vital leading-edge skills to approach community engagement from a unique cultural awareness perspective- putting community first, at the front-end of the project, by actively listening to and engaging with the very people that will be impacted by the project. This session is jam packed with essential information on how to create authentic community engagement, how to discover human patterns that organically exist in the community, develop solutions to mitigate impact, and how to honestly listen to the people in the community- in their own environment- where life organically happens. With this new knowledge gained, infrastructure- based companies will be able to incorporate community needs into the acquisition process. This course is ideal for infrastructure professionals, any ROW professional involved in program management, consulting, or project communications/negotiations, as well as anyone interested in learning this highly valued and in-demand skill set.

Course Objectives:

Through this course, you will:

- Learn how to sharpen your observation skills to notice community in action and human behavior patterns.
- Understand the influence of informal networks and learn how to interact with these networks to create opportunities for engagement.
- Learn how human geography affects the community and therefore your project.
- Recognize how to identify gathering places and why they are critical to project success.
- Become acquainted with informal network characters, such as natural communicators, in order to develop effective communication methods.
- Be able to identify citizen issues and address them in project design and implementation.
- Learn how to develop issue management strategies for aligning company and community interests in order to reduce social risk for your project.

Instructor:

Kevin Preister is an anthropologist from the University of California at Davis who lives in Ashland, Oregon. For 15 years, Kevin was a social ecology instructor for the Bureau of Land Management's National Training Center in Phoenix, conducting training workshops in rural towns across the West and promoting community-based solutions to natural resource issues. Through James Kent Associates he had numerous contracts to troubleshoot BLM and Forest Service projects using an Issue Management approach. He has also worked for corporations in many locations, helping them to understand and work with communities better, including commercial and residential development, power line corridors, highways and mining. He routinely works for local governments, a variety of federal agencies, and nonprofit organizations on natural resource issues, responsive governance, poverty reduction and urban redevelopment.

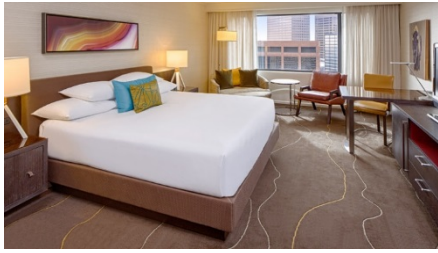

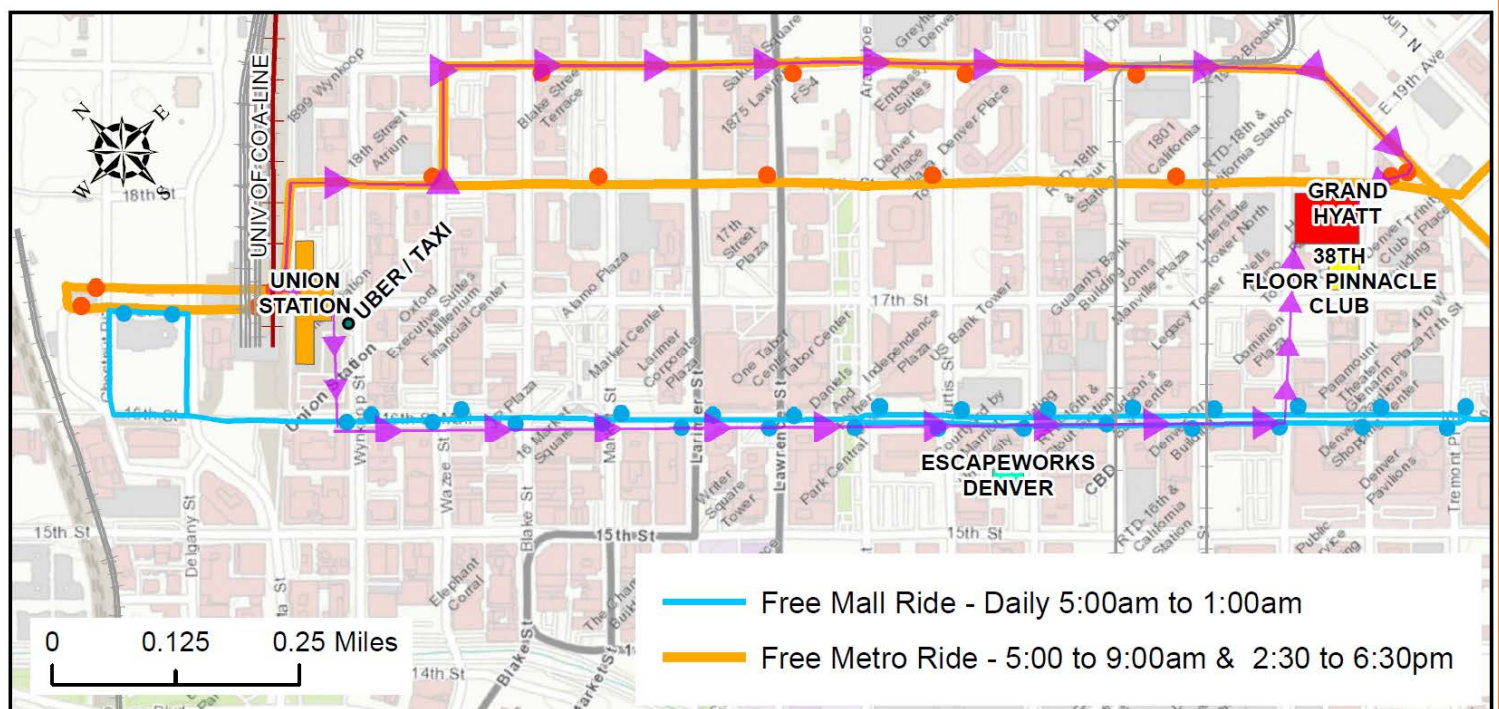
